Your data or some of these may still be retained to comply with specific legal obligations.

The providing of your personal data is always optional, however, <u>in the absence of data marked with an *</u> in the attached fax form and in any subsequent documents of data collection, <u>the service or part thereof cannot be supplied</u> and you could not receive the required services.

RIGHTS OF THE DATA SUBJECT

You can always exercise your rights including the right of free access to your data, the immediately updated or canceled of it for violating the law, to object to the processing of your data for purposes of commercial information or advertising, and to request the complete and updated list of all the data processors.

WHO CAN BE AWARE OF YOUR DATA

Your personal data you sent to Toscana Aeroporti S.p.A., will be processed by persons in charge of the processing in the management of the required services and by data processors. This privacy statement can be supplemented with additional information depending on the requested service.
